

Preparation Checklist

Create a powerful first impression

Lights		
	Turn on all interior and exterior lights -Replace burnt out light bulbs.	
Windows		
	Open all window shades, pull drapes, but keep windows closed.	
Rooms		
	Turn off ceiling fans and televisions. De-clutter and store extra miscellaneous/extra items in the garage or storage areas.	
Kitchen		
	Clear off counter tops. Remove hanging hand towels from sinks, cabinets, refrigerator, oven handles. Store paper towels, trash cans, and items on refrigerator out of sight. Remove floor mats and store out of sight.	
Ве	Bedrooms	
	Straighten/make beds. Remove items from nightstands, dressers, desk tops, etc. Clear personal/extra hanging items from walls.	
Bathroom		
	Clear off counter tops. Store or place floor mats and shower items (towels, bathrobes, soap, loofas, etc.) out of sight.	
Pets		
	Please make sure there are no pets that our photographer has to work around. If pets must be at the property, please place them in the garage or a comfortable room.	
Driveway/Yard		
	Remove all garden tools; including hoses and sprinklers. Place garbage cans out of sight (in garage or on the street). Move vehicles from driveways and do not park directly in front of the house.	



TERMS OF SERVICE

By using services through Visual Agent, you have agreed to be bound by these Terms of Service. Terms of Service described below will apply to all orders placed with Visual Agent. Visual Agent is not responsible for delays, failure to perform, or damages beyond reasonable control resulting from, but not limited to, weather, uncontrollable conditions, acts of God.

Visual Agent has the right to void any order and/or discounting working with an agent for any reason without warning. A full refund will be issued to agent for unfulfilled orders. No other terms or conditions apply unless specified in writing.

Platform Terms

An agent must complete a mandatory form to create an account with Visual Agent.

A username and password are required to gain access to Visual Agent's platform.

Visual Agent's platform allows access to order form and manage content/services.

Information collected is used to assist website to customize agent's account and automate the ordering process. All personal information is used for the purpose as requested by the site.

Visual Agent does not, nor will never, sell customer lists and/or names to any third parties. Visual Agent may disclose personal information if required by law enforcement.

Reschedule and Cancellation Policy

Agent agrees to the rescheduled and/or cancellation fees described below:

12-24 hours prior to appointment a \$25 fee is assessed to agent's credit card.

0-12 hours prior to appointment a \$50 fee is assessed to agent's credit card.

In case of weather events, agent will have the option to continue with the scheduled appointment or reschedule to the next available appointment timeslot. The agent is responsible for rescheduling due to weather. Visual Agent is not responsible for rescheduling because of weather.

A \$50 rescheduling fee will be assessed if the photographer is at a scheduled appointment but cannot access the property. Photographer will remain at the property for 15minutes past the scheduled start time.

Agent must have the property "photo ready" by the scheduled appointment. Visual Agent is not responsible for "preparing" the property. If conditions are unacceptable, a \$50 rescheduling fee will be assessed.

Price and Payments

Payment is required to complete the ordering process. Without payment, the order will be listed as "pending" and will not be eligible to schedule the appointment. If the order is "pending" the day/time requested will still be available or other agents to schedule.

Visual Agent guarantees professionally produced content. If standards are not acceptable based on reasonable standards, a refund will be issued, or in part depending on the portion of the content that is not acceptable. Visual Agent is responsible for the amount of the refund. Agent will not receive or be allowed use any refunded content.

Visual Agent will re-edit content based on the agent's written notes. An hourly fee may be assessed if the

agent is not satisfied but would like to continue refinement of the content.
